**LABELVIE S.A BOND ISSUE DATED DECEMBER 30, 2024
REVISION OF THE COUPON RATE FOR UNLISTED FLOATING-RATE
BONDS OF TRANCHES "A" AND "C"**

In accordance with the provisions of the minutes of the decision of the Chairman of the Board of Directors dated December 24, 2024, setting the terms and conditions of the ordinary bond issue through private placement by Label Vie S.A on December 24, 2024, which provides for an annual revision of the interest rate for tranches "A" and "C" on the anniversary date of the bond's enjoyment date, the new interest rates to be applied as of December 30, 2025, are as follows:
